Ken Sedlak made a motion to accept the November 30<sup>th</sup> Corporation minutes with Tori Haskins seconding. All in person members voted to approve with 15 online members voted to approve. Motion passed.

## **Presidents Report - Gina Kline**

- At the November Board meeting Jamie DiPace, Jeff Bernetich and Mark Wilson took their oath of office. Jamie DiPace was voted for a 3 year term, Jeff Bernetich was elected and will fill the vacancy on the board and that is for 2 years, Mark Wilson was elected for a 3 year term.
- Officers for the board was voted on and the following is the results: Gina Kline President, Jamie DiPace Vice President, Brian Baldwin Secretary, Kristen Shaw Treasurer, Steve Gwizdak Assistant Treasurer and Jeff Borges Committee Executive.
- At the December 21<sup>st</sup> board meeting with the chiefs the board collaborated with the chiefs to make a list of priorities that the board and chiefs should work on this year. The board also discussed the duties of a department chaplain and what type of position should be. If anyone knows of someone or if a member feels they would like to take this position please talk to either Brian Baldwin or Chief Appell. This position does not need to be an ordained priest of minister. It could be a deacon of a church or anyone who would be able to help members when there is a death in the family and this person would be the contact person for whatever the family needed. The board has been working on an appraisal form to evaluate the chief's performance and give him positive and constructive feedback on some things that he might be able to do that he is doing really well and things that he has the opportunity to improve on. The board is hoping to approve this document at the next board meeting and do a formal review process with the chief.
- The board decided to put the board modernization efforts on hold at this time. There is a number of other priorities that the board is looking to focus on this year and the president will present them at a later date.
- Based on all the items that were brainstormed we are going to be putting together strategies that are
  really going to be the drivers of what we focus on for the coming year. The areas of focus will be
  recruitment training, including leadership development, communication and expense reimbursement,
  the point system. There are a lot of ideas and thoughts that were discussed that fall into some of those
  categories. One the board has looked at all the information the board will come to a conclusion on what
  those priorities are going to be and will report back to the membership.
- The board also talked about the Communications and Public Relations Coordinator roles. Sot this is really the person that serves on the committee as the chair of the Communications Committee. The board drafted a job description for this position to clarify what it is that the board needs this person to do. # **Treasurer's Report: Kristen Shaw**

• Kristen noted the expenses through December 31, 2023. Some of the expenses that the Corporation are responsible for the Hartford County Chiefs Dinner expenses were \$757. Company 2 new propane tank and propane \$1,536.00. The Annual Dinner expense was \$15,412.00. The awards expenses were \$8,532. Fundraising as of December 31, 2023, is \$51,540.

## **Town Representative Report: James Speich**

• The building committee approved Tecton Architect firm out of Hartford and made a recommendation to the town council to approve Tecton. The town council approved and the town has signed a contract. The price to do plans to renovate Company 1 and 4 and to do a new Company 3. There may be additional cost once the architects get a chance to look in the stations. Now it will be up to the members to let the board and the chief know what they would need in the renovated stations and the new Company 3. Once the architect gets going on the plans then the department members, officers and board will have their say in what they would like to see in the plans at each station. Members should come to the Building Committee meetings to see what is being discussed so you have a better idea of what items are being discussed. The architect will be at the February meeting.
