- Looking into leasing a mobile office trailer for Company 3 for gear for around \$9,500 per year or we buy a used one for \$41-\$50k. The Chief is also looking at a carport for behind Company 4 around \$5k.
- Will be looking to do repairs at Company 2. Will put a package together of all items that need to be repaired or replaced.
